As of June 30, 2024, the Fund’s aggregate NAV was \$7,087.3 million, the fair value of its investment portfolio was \$11,122.2 million and it had principal debt outstanding of \$4,295.9 million, resulting in a debt-to-equity ratio of approximately 0.61 times.

Status of Offering

The Fund is currently publicly offering on a continuous basis up to \$8.0 billion in Shares (the “Offering”). The following table lists the Shares and total consideration for the Offering as of the date of this filing (through the July 1, 2024 subscription date). The Fund intends to continue selling Shares in the Offering on a monthly basis.
