As of June 30, 2024, the Fund's aggregate NAV was \$7,087.3 million, the fair value of its investment portfolio was \$11,122.2 million and it had principal debt outstanding of \$4,295.9 million, resulting in a debt-to-equity ratio of approximately 0.61 times.
