This Final Amendment relates to the Issuer Tender Offer Statement on Schedule TO (the "Statement") originally filed on August 1, 2024 by HPS Corporate Lending Fund (the "Fund") in connection with an offer by the Fund (the "Offer") to purchase up to 13,888,086 of its outstanding shares of beneficial interest (including Class I common shares of beneficial interest, Class D common shares of beneficial interest, Class S common shares of beneficial interest and Class F common shares of beneficial interest, collectively, the "Shares") at a price equal to the net asset value per Share of the applicable Class as of September 30, 2024 (the "Valuation Date"), upon the terms and subject to the conditions set forth in the Offer to Purchase filed as Exhibit (a)(1)(ii) to the Statement (the "Offer to Purchase").

This is the Final Amendment to the Statement and is being filed to report the results of the Offer. Capitalized terms not otherwise defined herein shall have the meanings ascribed to them in the Offer to Purchase.

The following information is furnished pursuant to Rule 13e-4(c)(4):

- 1. The Offer expired at 11:59 p.m., Eastern Time, on August 29, 2024.
- 2. 1,766,987 Shares of the Fund were validly tendered and not withdrawn prior to the expiration of the Offer.
- 3. The net asset value of Shares tendered pursuant to the Offer was calculated as of the Valuation Date in the amount of \$25.56.
- 4. The payment of the purchase price of the Shares tendered was made in the form of a non-interest bearing, non-transferable promissory notes respectively issued to the Shareholders whose tenders were accepted for purchase by the Fund in accordance with the terms of the Offer. Pursuant to the promissory notes, the Fund paid on or about October 31, 2024 to the tendering Shareholders a total of \$45,159,001, representing the net asset value as of September 30, 2024 of the total amount of Shares tendered by Shareholders upon the terms and subject to the conditions set forth in the Offer to Purchase. The Shares were repurchased as of 4:00 p.m., Eastern Time, on the Valuation Date.

Except as specifically provided herein, the information contained in the Statement, as amended, and the Transmittal Letter remains unchanged and this Amendment does not modify any of the information previously reported on the Statement, as amended, or the Transmittal Letter.
